

Incident Report for SBL Listing SBL51828

On 1 March 2007 Spamhaus created SBL record SBL51828 listing 63.161.113.0/24 (255 IP addresses from 63.161.113.0 to 63.161.113.255) due to spam being sent from anonymous domains in that range.

The 63.161.113.0/24 netblock was found to be registered to "Rocky Mountain Internet Services, LLC" of Colorado, registered as:

Its domain name, rockymountaininternetservices.com, was registered to a Florida company, Moniker Privacy Services of Pompano Beach, FL, to hide the real owner.

On examination by the Spamhaus Team, the 63.161.113.0 netblock contained 65 anonymous domains all registered to, and therefore declared to be owned by, a Florida company: Moniker Privacy Services of Pompano Beach, FL.

All 65 domains were created using 'random' names, a pattern Spamhaus knows is used solely to create "throwaway" domains used for spamming (the sender abandons each domain after a certain number of complaints and moves on to the next).

The full list of the 65 domains is on page 6

The domain registration (ownership) records for each of the 65 domains follows from page 8 onwards.

A sample of spam sent from one of the anonymous domains, "gotdop.com" is on page 4. The anonymous domain registration record for gotdop.com is on page 8.

Although like the other 64 domains, gotdop.com is anonymously registered in Florida, it claims at the bottom of the message to be "Gotdop.com, 39555 Orchard Hill Place, Suite 600, Novi, Michigan, 48375".

Nothing in the IP address registration, domain registrations, nor even in the spam sample itself, even remotely showed any connection with e360 Insight or David Linhardt. At the time of creating the record it was technically impossible for Spamhaus to know that the IP range the spam was coming from and these domains were owned by David Linhardt.

Only on detailed examination of the Delaware corporate registration of the anonymous Rocky Mountain Internet Services, LLC, did Spamhaus find a clue that the company was yet another alias of David Linhardt/e360 Insight. Confirmed when the Plaintiff's counsel sent Spamhaus' counsel a demand for SBL record SBL51828 to be removed, claiming it was in violation of Judge Kocoras' order to never list David Linhardt's domains or IPs.
